## WARRANTY

Pro-Tec products are fully warranted to the original owner against defects in materials and workman ships for the period of one (1) year from the date of purchase. The warranty does not cover damage caused by accident, improper care, negligence, laundering, normal wear and tear, or the natural breakdown of colors and materials over extended time and use.

For warranty evaluation, the purchaser must return the product to the Pro-Tec dealer where he/she purchased with the original purchase receipt. We require that all products are in clean condition. Products that are dirty will be rejected and returned to the sender, charging freight.

Any product that is defective will be replaced by Pro-Tec if returned within one (1) year of purchase. The returned product should be carefully wrapped and shipped prepaid to: Pro-Tec Warranty Department, 12801 Carmanita Road, Santa Fe Springs, Ca 90870.

Together with:

1. The registration card (if not already sent).
2. A letter stating the reason for the return, including a return address.
3. A proof of purchase with date.
4. A check payable to Pro-Tec for \$10.00 return shipping and handling.

## USER INSTRUCTIONS

Warnings: For use in non-motorized recreational sports (such as pedal cycling, skateboarding, or roller skating), for recreational snow sports (such as skiing, snowboarding, and other alpine sports), and for water sports (such as canoeing or whitewater sports), dependent upon which helmet you purchase. No helmet can prevent against all injuries, serious injury or death may occur Pro-Tec makes no claim that this helmet will eliminate all possibilities of injury.

This helmet is not designed for motor vehicle use and not for sports other than those for which it was certified. Every time you use this helmet check that nothing is badly torn, worn, missing, or out of adjustment. This helmet should not be used by children while climbing or doing activities when there is a risk of the child hanging himself or herself. For proper fit, follow instructions below.

### Fitting Instruction:

1. The helmet can only protect if it fits well. The buyer should try different sizes and choose the size that feels secure and comfortable on the head.
2. Adjust the strap so that they form a "Y" forward of and below the ear. Adjust the strap to be comfortable yet snug. Then close the fastening system and position the strap under the jawbone and against the throat. If the helmet fastens with a D-Ring, fasten the chinstrap by looping the end of the strap first through both D-Rings, then back through one (1) ring. Tighten the strap by pulling the loose end. With the helmet on and tightly fastened, make sure the helmet cannot be removed from your head or rolled backwards or forward excessively. Be sure that the buckle is not against the jawbone.
3. When properly fitted and adjusted, your ears your ears should not be covered by any part of the strap.
4. Make sure you can see clearly and your peripheral vision is not blocked.

### Care Instruction:

For cleaning, use a soft cloth, mild soap and water, rinse and then air dry only. The protection given by this helmet may be severely reduced by the application of paint, adhesive stickers and transfers, cleaning fluids, chemicals, petroleum and petroleum products, and other solvents. The helmet will be damaged if exposed to temperatures exceeding 62C (150F). Never remove or modify the original elements that constitute the helmet, or add accessories not recommended by the manufacturer, as it may risk cancelling the protective role of the helmet. During transportation, do not expose your helmet to impact or external force. Store in a dry place away from heat, for example, a radiator or direct sunlight through a car window.

### Replacement:

This helmet is designed to absorb shock through partial destruction of the energy absorbing liner. This damage may or may not be visible to the user. After a severe impact or blow, deep scratches or other abuse, this helmet should be destroyed and replaced even if it appears to be undamaged.

### For Snow Helmets:

Class A and Class B helmets are for alpine skiers, snowboarders and similar groups. Class A helmets offer comparatively more protection. Class B helmets may offer greater ventilation and better hearing, but protect a smaller area of the head and give a lesser degree of protection from penetration. This helmet has no suitable accessories.

### For Water Helmets:

This helmet is conceived to help protection against bumps, scratches and shocks. This helmet is not foreseen to be used in whitewater classes 5 and 6, as defined by the International Canoe Federation.

## PRO-TEC DUAL DIRECTION FIT SYSTEM

The Pro-Tec Dual Direction Fit System is a half ring retention system designed to provide the user with a perfect helmet fit. An adjustable plastic or wire band is attached to the inner rear portion of the helmet, and can be loosened or tightened to provide a comfortable, secure fit.

The Dual Direction Fit System, combined with the helmet chin strap, securely holds the helmet in place on the users head. To adjust the Dual Direction Fit System, place the helmet on the user's head and turn the adjuster dial (Figure A) counter-clockwise to loosen the retention system, or clockwise to tighten the retention system until securely fitted.
